



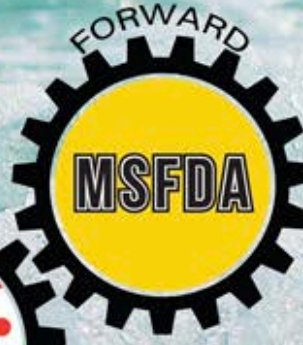

It is advisable to bring sunscreen, a hat and sunglasses, and dress for cooler temperatures than the forecast. A rod and reel are included in your fee along with hooks, sinkers and bait. If you desire, you can bring your own rod, reel and tackle. You can also bring a cooler, however, a bucket to use or a bag for your fish will be provided. You can get your fish cleaned and they will fillet your catch for a nominal fee. Participants will meet at Bahia Marina on 22nd Street, right next to Fish Tales Bar & Grill. Parking is available.*

Continuing Education Credits

Speakers & Topics

This session will help attendees better understand the dynamics of managing change, learn the creative problem-solving process, and learn skills to improve one's creativity. Mark has one of the most diversified backgrounds in the speaking industry having owned and operated several businesses ranging from livestock production to nightclubs to golf instruction, and also spent ten years as a lobbyist in Washington, D.C. and in thirteen state legislatures for a Fortune 500 company. That business experience combined with his work as a nightclub performer allowed him to create truly unique presentations. His tagline is simple: **Solid Business Wisdom in a Brilliant Comedic Style**. He is one of the rare individuals in the world who is equally adept at performing comedy shows or high content speeches. He has received rave reviews sharing the stage with a wide variety of celebrities like Paul Newman, Peter Frampton, Colin Powell, and Bob Newhart, and has introduced a President of the United States on a live, nationwide television broadcast. Mark is author of several business books and two joke books including his latest "Morph," a guide to accepting and managing change, and has spoken to a "Who's Who" list of corporations, conventions, and trade associations over the past four decades. He was raised on a farm, received two degrees magna cum laude from Kansas State University, and taught school before he began his lobbying, business, and speaking career. He has received the Certified Speaking Professional (CSP) designation from the National Speakers Association and been inducted into their Hall of Fame. He is happily married to Terry, Grandpa to Delaney, Archer, Reid, and Everett, and the proud father of two amazing daughters, Leah and Lindsay. His hobbies are golf, basketball, and music. From comedy shows to seminars, Mark's philosophy is simple...*say it with humor and people will take the message home.*



Marguerite Ham will provide a two-part interactive workshop on team skills for success. Attendees will evaluate their team and identify challenges, understand the four stages of team development, identify "time busters" that crash productivity, and learn the five steps to completing any task, and more. Marguerite has been a corporate trainer since 1989. She gives over 75 presentations a year nationwide to organizations such as Lockheed Martin, American Family Insurance, Lucent Technologies, Bell Canada, Selected Independent Funeral Homes, and associations and organizations worldwide. Marguerite is a certified coach and has been a certified, executive corporate coach for the last 15 years, where she helps organizations implement the coaching culture through training and coach certification. In addition, she works with corporate executives and their management teams, guiding them to be more effective and efficient while being in alignment with the organizational values and goals as well as their own. She is the author of: **Total Recall** (audio series), **How to Remember Anything in 60 Minutes or Less**, **How to Remember "What's His Name?"** and she is currently writing her latest book, **The Five Languages of Leadership**. Marguerite is known for her highly interactive, lively, content rich presentations in the fields of memory, leadership development, team effectiveness and coaching. Marguerite lives in Elizabeth, Colorado, with her husband, Gary, and his two children, Nick and Julia. Marguerite started an organization, Eye of the Storm Foundation, in memory of her son, Matthew, who passed away in 2011 from an accidental overdose. She educates young adults on the dangers of the misuse and abuse of prescription drugs.

Charles T. "Chuck" Bowman, CMSP, CFSP, CCO, will present an update on behalf of the National Funeral Directors Association. Chuck is the 2017-18 president elect of the National Funeral Directors Association. Chuck's career in funeral service began after working for many years in law enforcement. He joined Brenneman Funeral Home in Liberal, KS in 2017. He spent most of his career with Horan and McConaty, which operates several locations in the Denver, CO area. Chuck was extremely active in the Colorado Funeral Directors Association (CFDA) for a number of years. In addition to service on the Disaster and Legislative Committees, he was a member of the CFDA board of directors, serving in the role of president in 2003. He is the chair of Arapahoe Community College Mortuary School Advisory Board. In 2014, he retired from his role as deputy commander of the Region VIII DMORT. Most recently, Chuck served on the NFDA Board of Directors as an at-large representative, secretary and treasurer. He previously served as Colorado's representative to the NFDA Policy Board. He has also served on NFDA's Disaster Committee and Metals Recycling Task Force.



Speakers & Topics (continued)



John O. “Jack” Mitchell, IV, CFSP, CCO, CCSP will present *Listening to the Consumer’s Voice*. In this session, attendees will be able to position their business based on consumer attitudes and expectations related to funerals, cremation and memorial service; enhance offerings based on consumer preferences; and improve their communication and connection with consumers based on consumer trends. Jack is an at-large representative to the NFDA Board of Directors. He is a sixth-generation funeral director with Mitchell-Wiedefeld Funeral Home in Baltimore, Maryland. He also operates John O. Mitchell IV Funeral Services of Dulaney Valley since its inception in 2007, when he and his father became the owners of Dulaney Valley Memorial Gardens. Jack graduated from McDonogh School in 1989; he went on to serve as president of the school’s Alumni Association for the 2007-2008 term and currently serves on the Board of Trustees. He graduated from Lehigh University in 1993 with a Bachelor of Science degree in Business Management, and from Catonsville Community College in 1995 with an Associate in Arts degree in Mortuary Science. Jack has extensive experience serving on committees with both the Maryland State Funeral Directors Association (MSFDA) and NFDA. He is a past president of MSFDA and is Maryland’s former representative to the Policy Board.

David R. Fowler, MB, Chb. M. Med, FAAFS, FCAP, FNAME, CABP, is the Chief Medical Examiner for the state of Maryland. He oversees a death investigation system for a population of almost 6,000,000 people in 23 counties and Baltimore city. He graduated from the University of Cape Town in 1983 and did a year of general medical and surgical internship, followed by a year of pediatric pathology at the Red Cross Children’s Hospital in Cape Town. He then started and completed a five-year full-time training program in forensic pathology at the University of Cape Town earning his master of medicine in forensic pathology. This was followed by additional training in the United States at the University of Maryland and the Office of the Chief Medical Examiner for the state of Maryland. In addition to his specialist qualification from South Africa, he is also board certified in anatomic and forensic pathology by the American Board of Pathology. Dr. Fowler is an Associate Professor at the University of Maryland in the departments of pediatrics and pathology, adjunct faculty at the University of Baltimore, faculty at the National Study Center for Trauma and EMS, the Johns Hopkins Bloomberg School of Public Health Injury Center, George Washington University, and Visiting Professor at multiple other universities. He is part of the editorial team and author of several chapters in new publications on forensic neuropathology and forensic pathology as well as having contributed chapters in emergency medical textbooks and forensic pathology textbooks and has co-authored over 80 peer reviewed journal articles.



James Govoni, president of the Maryland Board of Morticians & Funeral Directors, will present the preneed law session as well as participate on the *Best Practices Panel*. Since 2000, Jim has served as General Manager of Hardesty Funeral Home with Maryland locations in Annapolis, Galesville and Gambrills. Jim began his career in funeral service after a four-year tour of duty in the United States Navy Hospital Corps. While stationed at the Bethesda Naval Hospital, he worked part time for the Robert A. Pumphrey Funeral Home, P.A., Bethesda, MD where he became an apprentice mortician in 1982. He attended the Catonsville Community College, graduating in 1984 and obtaining his mortician’s license in 1985. In 1987 he joined the then Beall Funeral Home in Bowie, MD. The firm was sold in 1989 and became the Beall-Evans Funeral Home, changing in 1993 to the Robert E. Evans Funeral Home. Jim became manager in 1997. Jim is a member of Dignity USA/Washington, West Annapolis Business Association, and the International Society for Performance Improvement, Potomac Chapter.
